1. This is a Doubles and Singles tournament with an optional all events. Bowlers may reenter both Singles and Doubles. Bowlers may only place one time in the final prize list in singles and only one time in doubles with the same partner. First scores used will be for all events. Age will be determined as of January 30, 2018.
2. Bowlers will use their highest sanctioned USBC average from the 2016/17 season minimum 21 games. Bowlers with no 2016/17 average may use 2016/17 summer average minimum 21 games (verification required). Read USBC rule 319A-3. Rule 319A-2 will not apply, rule 319B bowler with no acceptable average will bowl using a 220 scratch average. Rule 319C & 319D will be waived.
3. Handicap will be 90% of 220.
4. Entry Deadline is one hour prior to last scheduled squad of the tournament. Walk-ins accepted based on lane availability.
5. When qualifying scores are tied for handicap and scratch prizes of the same value the scratch prize will be awarded first.
6. Bowlers are asked to check in ½ hour before scheduled squad time. Bowlers may need to show sanction cards at check in.
7. Bowlers may request to bowl singles on different squad than doubles. Must be noted in preferred dates and times box.
8. Rules not covered will revert to the tournament rules in the USBC rule book.
